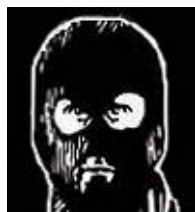

My reply to Randy Richmond's article.

A London man's postings on websites target blacks, Jews and gays. RANDY RICHMOND, Free Press Reporter 2004-08-19

Why didn't you mention Christians and skinheads in the title too? I try to be evenhanded. I strongly criticized religious establishments, not only Christians, on numerous occasions. I'm not only critical of Negroes, certain Jews and queers in general. Police have launched a hate crimes investigation of a London resident who regularly ridicules blacks, Jews and gays on the Internet. London police confirmed the investigation yesterday, just as four Ontario anti-hate groups and an Ottawa human rights lawyer publicly called on the province and London's force to investigate the man.

White Europeans are constantly vilified in, what is for most part, mass media owned by Jews. Even wonder why agent Smith in "The Matrix" saga is an evil looking 'white guy'? The joint call for action is also a response to the attorney general's recent calls for Ontarians to help fight racism.

racism n. The assumption that the characteristics and abilities of an individual are determined by race and that one race is biologically superior to another. || A political program or social system based on these assumptions. racist n. and adj.

London police can say little about the investigation except that it has begun, Const. Jeff Arbing said.

Investigators are looking at the issues raised in the letter released by the four groups yesterday, "and beyond what the letter covered," Arbing said.

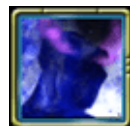

Keep free speech alive, hate and all. Fuck the enemy.



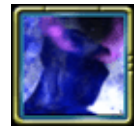

Arrests raise fears racist group growing RANDY RICHMOND, Free Press Reporter

Four London area men -- including a white supremacist -- have been charged after Toronto police found knives, a bow and arrow and a bullet-proof vest in a car heading to a protest. Three of the men are not known to local police or anti-racist activists, raising the possibility the local movement is gathering a new wave of supporters.

One man was found carrying a throwing knife, Toronto police said yesterday.

"You have no need to have throwing knives. And driving in the city with a bow and arrows, that is going to raise our suspicions," said Det. John Ihasz of Toronto Police 23 Division.

As for a bullet-proof vest, "What is your reason for having that? It concerns me," Ihasz said.

The knives "are specifically designed to be thrown," he added.

They don't have a handle, but the blades have bolts on either side to make throwing easier, he said.

All four men are charged with having weapons at a public meeting and possession of a weapon for a dangerous purpose, Ihasz said.

One of the four, **Thomas Winnicki**, 28, of London, was also charged with carrying a concealed weapon. He was driving the car, Toronto police said.

Winnicki is well known to anti-racism activists.

Four Ontario anti-hate groups publicly called on the province and police last month to investigate Winnicki's Internet postings, calling them racist.

London police have confirmed they are investigating Winnicki for possible hate crimes. Winnicki is also the subject of a Canadian Human Rights Commission complaint.

The other three men charged were Kevin Lovett, 33, Randall Linton, 25, and Jason King, 25, all from the London area, Toronto police said.

Those men are not known to London police, said Const. Jeff Arbing.

"Any of these groups, they are always trying to recruit new members."

Ottawa human rights advocate Richard Warman said he and other anti-racism activists had not heard of the others

charged either.

That may be a sign white supremacists groups are growing in the London area, Warman said.

"They could be the second wave."

Or it may be that the other men were simply in the background before, he added.

London is known to have a small but vocal group of white supremacists.

The four men were travelling to a protest at the Metro West detention centre Sunday where holocaust denier and white supremacist leader Ernst Zundel, 64, remains in solitary confinement.

He is being held on a security certificate while the courts determine if he should be deported.

Sunday's protests turned violent when pro-Zundel supporters met counter-demonstrators at a Toronto restaurant.

Toronto police said a number of small brawls terrified staff and patrons.
