Bob, you appear to be new here so I will put this matter into focus for you. Right now you are looking at the Doles fundraiser all wrong. Plus you have made factual errors. I'll try and sort this out, as I have before.

Here's a few good reasons why people got \$ together for Doles. But first, lets start off and recognize that it was not "our movement" it was **the leaders of the Dole fundraiser, Alex Linder and his matching donor Jimmy Teuton, and the many generous and kind and caring people who gave to the project at VNN**, which was lots of people-- but not any amorphous "movement." Now, people gave to Chester's defense because 1) Chester was a great UC for the NA, and had a very large local group, that was very active in publically promoting our points of view, 2) Chester has done his part for bringing forth new White kids, including one very small infant at the time of his arrest and a wife who needed our help, 3) Chester was entrapped and railroaded, not unlike Hale, but also selectively prosecuted for a "crime" that every nig in the neighborhood is in violation of any nobody seems to care. Ha, by contrast, Chester was DENIED BOND. Incredible. 4) Chester chose a competent defense team who was highly qualified in criminal defense in that location.

NOTE: Chester chose his lawyer -- not VNN. VNN helped Chester and his family. The public facts are these: the retainer was 50k not 75. 75 was what was raised and one presumes the balance has gone to the benefit of the Doles family. As to whether any retainer was refunded or not, that we do not know but in a situation like this I would expect that this had occurred. That is private and if Mrs Doles has not aired that fact on SF like she has many other I am sure she has good reasons not to. But you are grossly in error on multiple facts. Another error is that Barr

fobbed her off on junior counsel. Ed Marger, we later found out was Jewish. Chester was not the first WN to have a Jew lawyer, btw, and in some places one couldnt find a lawyer who isnt a jew. But anyhow, Marger is an accomplished criminal defense attorney as much or more so than Barr. Barr appearing in court or not was inconsequential. Barr is a name, that is why he was part of the team. Barr is a rainmaker not a technician. Perhaps you refer to Marger's daughter. Marger's daughter is one of a very few people in that firm and yet her resume is not lacking either. So "junior counsel" is not a fair characterization of that situation either.

But anyhow, Chester made his own choices. He chose his law team, and it was a reasonable choice. He chose to plea, and perhaps that was a reasonable choice. I was plenty disappointed by this but one can only imagine the forces that are brought to bear in such a situation particularly when one is threatened with one's wife being charged as an accessory. That would not have been good for the little tyke to have both parents in the clink and so I can totally understand.

Finally, the money was raised for a specific purpose. Saying, oh it should have been used for something else, is bullshit. It was raised for the purpose it was used for and the fundraisers did not have the latitude to switch directions once the gifts were made. So that is poisonous defeatist horseshit. If you cant find a better use for 75k fundraiser, go ahead and raise the money and lead by example. Otherwise dont come on here and bitch about old victories that you think were defeats.

And for VNN it was a victory. Linder showed us, along with all the donors, how we could come together and accomplish something. We are not just atomized, powerless, deracinated, marginalized freaks. We are family men, hard workers, smart when we put our minds to it, resourceful when we need to be, and we will strike again.

Now you put this in the Hale fundraiser for a reason, presumably. I dont know what the reason is, but the reason I started the thread was to raise fund to help him pay for the lawyers he had when I started this. And really, I felt remiss for starting it late. I should have done more to help Matt. But I know that Matt Hale is ten times tougher than anybody thought he would be, he has not recanted or begged for mercy, he has hung in there like a fucking STUD. He is working on his appeal and I think he has some definite grounds for reversal. WHY dont you get off your ass and send his dad \$5 for Matt's commissary as I'm sure it sucks being in the cage and rather than just show up and cast aspersions, you might rather do something positive.

So to summarize, the policy "we" have is the same one we had before. Help our friends and rain hellfire and brimstone on our Enemy. Stick around and get in your licks, its going to be fun if you like the sweet taste of revenge. Before you know it you may even find yourself sticking your neck out and standing a little taller and walking a little more ERECT.
