 the Applicant;

THIS COURT ORDERS THAT the interlocutory injunction is granted, pending a final decision by the Canadian Human Rights Tribunal in proceedings before it. As a result, the Respondent, Tomasz Winnicki, is restrained from communicating, by means of the Internet, messages that are likely to expose persons to hatred or contempt by reason of race, national or ethnic origin, colour or religion, contrary to section 13(1) of the Canadian Human Rights Act.

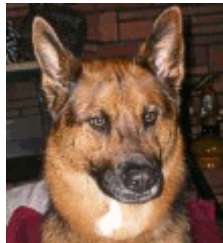

**C A F E comments on Winnicki case**

The following is Paul Fromm's most recent commentary on the Winnicki case:

Dear Free Speech Supporter:

The Canadian establishment has long "chased the Dragon" – prostrated itself in front of Red China hoping for the trade pot of gold at the end of the rainbow. From Mao admirers like [Pierre Trudeau](#) to silly "Team Canada" trade mission cheerleaders like [Jean Chretien](#), our political elite has shown a remarkable comfort level with this totalitarian regime. Right now Red China is well into another campaign to crack down on free speech on the Internet.

So, too, is the highly politicized and debased Canadian justice system. Canada has just gained another political mute in the person of London dissident Tom Winnicki. In a classic example of police state – sentence him first and have the trial later – a federal court judge has enjoined Tom Winnicki from using the

Internet to criticize (“expose to contempt”) privileged groups. The Canadian Jewish News (October 14, 2005) enthused: “Last week, [Judge Yves de Montigny](#) ordered Tomasz Winnicki of London to refrain “from communicating, by means of the Internet, messages that are likely to expose persons to hatred or contempt” because of their religious, racial or national background. The interlocutory (interim) injunction is precedent setting, Warman, an Ottawa lawyer, said, because ‘for the first time a Federal Court has issued an injunction relating to Internet hate.’ Previous interim court rulings dealt with hate messages distributed through the telephone system, he said. Although the court had not released the reasons for its ruling when The CJN went to press, Warman said the decision shows courts can restrain objectionable content from the Internet pending disposition of the case before a human rights tribunal.

## Federal Court injunction bars supremacist messages from Web

In Richard Warman's one-man battle against Canadian white supremacists, last week's decision by a Federal Court judge marks yet another victory – one he believes set an important precedent for future cases.

Last week, Judge Yves de Montigny ordered Tomasz Winnicki of London to refrain "from communicating, by means of the Internet, messages that are likely to expose persons to hatred or contempt" because of their religious, racial or national background.

The interlocutory (interim) injunction is precedent setting, Warman, an Ottawa lawyer, said, because "for the first time a Federal Court has issued an injunction relating to Internet hate." Previous interim court rulings dealt with hate messages distributed through the telephone system, he said.

Although the court had not released the reasons for its ruling when The CJN went to press, Warman said the decision shows courts can restrain objectionable content from the Internet pending disposition of the case before a human rights tribunal.

Warman launched a complaint two years ago alleging that Winnicki breached the Canadian Human Rights Act by using the Internet to communicate hate messages. He initiated the complaint based on material Winnicki allegedly posted on his personal website and on material carried by a U.S. White supremacist website.

Warman alleges that Winnicki posted messages that attacked Jews and other groups. One message warned "we are coming for you, you Jew f...s, you and your servile dogs too."

Warman also alleges that some of the messages attacked him personally by posting his picture, suggesting he is a Jew (he is not) and a enemy.

Although the case has been before a human rights tribunal for months, Winnicki has continued to post other hate messages, Warman alleged.

The interlocutory injunction will prevent Winnicki from doing so pending a resolution of the case, he added.

Len Rudner, director of community relations for Canadian Jewish Congress'

Ontario region, said the court has pre-empted Winnicki from posting problematic Internet content. "I think the decision of the Federal Court is an important statement on the position that Canadian laws take on the question of alleged hatemongers," he said.

The Winnicki case, which will reconvene on Oct. 17 in Toronto, is one of 12 Warman has launched in the last 2 1/2 years that involve leaders of extremist groups. All relate to the Internet.

Warman, who worked for the Canadian Human Rights Commission for two years, said he is targeting extremist leaders in a strategic and concerted manner.

If we go after a small number of leaders, the white supremacist movement can be eradicated, he said.

"I'm doing this due to fundamental human rights, I guess. It would make it difficult for me to sleep at night knowing someone is calling for the expulsion of my neighbours because they are Jewish or black," he said. []
